 The cartons were stacked too high, more than 6 feet / 1.8 meter high.

 The cartons were placed on the ground directly in warehouse.

 Glasses of window were broken in the warehouse.

 Some water was found on the floor in warehouse, but no wet carton was found.

 The workers did not pay extra attention during handling or re-packing.

 Inspection room was too small for a smooth inspection.

 The factory could not provide gloves to inspector when necessary during the inspection.

 The inspection room was too dark for a smooth inspection.

 The products were not manufactured in this factory (production lines were not found).
